



The Transgender Scam

A very real Hypothesis

The aim of this paper is to set out a realistic hypothesis. In the time tested tradition this hypothesis is based on overwhelming evidence of “cause and effect” that the author challenges the scientific community to prove or indeed disprove with hard scientific evidence.

The “Self” and Human Development

Let’s first start with four terms most frequently used in the context of personality theory: the “Self” and the “True Self” versus the “False Self”, and the “Identity” or “Self-Identity”.

The “Self” in general refers to one’s own being that distinguishes a person from others. Other words for the “Self” are: person, personality, identity, the totality of a person, the individual. The core: The sum total of a person’s characteristics distinguishes a person from others. Part of this concept is the mind with its mental functions.

The “True Self” stresses the authenticity and genuineness of the totality of a person’s characteristics and potentials. A “True Self” is expressed also in behavior, social interactions, and in dealing with the environment. True love comes from a “True Self”, but it requires an all-sided holistic, psychological (mental) and spiritual personal development with high ethical attitudes. Inner biographical catharsis is indispensable in order to reach this ‘quality’ of “True Self”.

The “False Self” is in contrast to the “True Self”, which stresses artificial characteristics, forced expressions, brainwashed character traits, distorted mental or behavioral expressions, superficiality, suppressed feelings, perverted mental functions, self-alienation, etc. The potentials of a “True Self” are unrealized, suppressed and stuck or perverted. We refer to this as a malformed or ‘dehumanized’ person.

The “Self-Identity” in general, refers to the totality of a person’s individuality, wholeness and potentials. The term means the “organized wholeness”. The term “Self-Identity” does not distinguish between ‘good’ and ‘bad’ or ‘moral’, ‘true’, ‘distorted’, ‘neurotic’ or ‘disordered’. Self-Identity includes the gender ‘male’ or ‘female’. Socialization is a role distribution and does not question and never eliminates the gender as ‘sex by birth’. This totality creates an individual and distinctive being.

Transgender

Now, let’s explore the term ‘transgender’, which is mostly defined in a broad and vague manner. Based on many experts’ definitions, we conclude: the concept ‘transgender’ is a confusing game of words with multifaceted and vague definitions. “Transgender” as a concept does not aim to encompass all characteristics of a person in order to form a complete “Self-Identity” or a “True Self”.

In this concept nothing is explored about a “False Self” although in general this is a crucial characteristic. The “False Self” doesn’t exist because the concept of transgender is within itself a “false” concept. At the very beginning of exploring the “transgender” concept we see a patchwork full of fragmented nonsense.

Experts say: “transgender” refers to the individually preferred and chosen “Gender Identity” and not to sexual orientation or physical sex characteristics or genital abnormalities. The term ‘Gender’ has nothing to do with sexuality (genitals, sexual organs, and sexual practices). “Transgender” is about how they feel inside; the inner sense of being male, female, or both. This is the transgender concept.

We interpret: But people can have many feelings and these feelings can change daily, weekly or monthly. There are many feelings a human can have at the very beginning of their life and during their entire life span; of which the “transgender-feeling” is only one.

We completely miss here a deep insight into theories and the reality of feelings (emotions). The “transgender feeling” is totally disconnected from the complex interrelations of emotions and their roots.

In many cases it is banal and highly simplistic. Transgender people say they were assigned a sex that isn't true to who they are. Some feel they are both male and female. Others don't identify as either gender. There is diversity of possible gender identities and presentations. More often the gender matter is on a continuum of 'more or less'.

'Gender' is an internal sense of being male, female, or other. But this 'sense' has no roots, not in the mind and not in the biology; it is constructed.

'Gender identity' is a psychological concept and state based upon internal senses - disconnected from all other possible and real identity characteristics. From a psychological perspective this is seen as very thin air.

The word “Gender” etymologically refers to sexual organs by birth, which can be male or female. The concept is evident since millenniums: “Man-Woman” and in that context “Mother” and “Father”. It is also related to the concept of the relationship “Man-Woman”, which traditionally leads to “Marriage” - with or without creating a baby and a “Family”.

The transgender concept not only cuts off all these precious human values but challenges the fundamental human concept of reproduction.

The term “Gender” is nowadays used beyond the established concept of male-female ('sex by birth'). The millennium old meaning of 'gender' is herewith distorted into a range of constructed new “Identities”, which are beyond sexual biology and sexuality; and are also beyond the concept of a relationship, marriage and family.

Sexuality as a fundamental characteristic (male and female sex by birth) is eliminated.

We see this as a conceptual manipulation with vague words and diffuse emotions. Its intention and effect is to destroy the principles of human development, which expresses itself as a mental disorder.

Transgender people identify themselves as heterosexual, homosexual, bisexual, asexual, transvestite, or they may decline to label their sexual orientation.

Although the transgender concept excludes the sexual organs by birth as a fundamental element of “Identity”, indirectly the context of 'genitals' and 'sexual preferences' (sexual activities, attractiveness) is indelibly present.

Therefore, this is a conceptual manipulation; they cheat reality by sticking their head into the sand. This has to be considered as a mental disorder.

It is highly improbable that a transgender male does not realize that he has a penis, respectively a transgender female a vagina and breasts. It is certainly 'normal' that humans have a certain interest in sexual excitement. This fact is fully ignored in all explanations related to transgender.

A boy that wants to be a girl or simply wants to ignore his penis has a problem with his penis and sexual excitements. The same is to be said about a girl that wants to ignore her vagina and breasts. Therefore, this is a very serious mental disorder.

It is said that transgender people identify themselves as a different gender than the sex they were assigned at birth. Males want their identity to be 'female'. Females want their identity to be 'male'. This is a psychological disorder.

The degree to which individuals feel genuine, authentic, and comfortable with their new 'gender identity' has been called 'transgender congruence'. It says there are 'degrees' from low to high congruence, e.g. from 10% to 100%. That means that a transgender can be a 'little bit transgender' or up to 'totally transgender'.

What is this if not a light or heavy psychological disorder or the fantasy of a lost expert?

There are a hundred differences between male and female that are not socially adapted but given by nature. A majority of these differences has a 'degree' from low to high congruence. It's the dynamics of wholeness that matters here.

Can transgender people really eliminate these one hundred and more indelible differences between man and woman by adapting a variety of new 'gender identities'? No! That's absurd.

Medical intervention to change sex organs is not part of the "Transgender" concept. Transgender people are called 'transsexual' if they desire medical assistance to transition from one sex to the other. Here the term 'trans' is applied in the context of 'genitals'.

The change of sexual organs integrates sexuality (the genitals) as an essential part of the (new) personal identity: The boy is now a girl with vagina, but also with male characteristics; and the girl is now a boy with a penis, but also with female characteristics.

The whole transgender and transsexual concept is a self-cheat and an aberration from neurotic academic "experts" who constructed this distortion, with their hidden intention of destroying the archetypal evolution.

It is said that the desire to transition from one sex to the other (without given organ abnormalities by birth) arises already during early childhood as a result of a previous transgender identity process. In other words: the boy doesn't want his penis. He wants a vagina. Do all transgender boys age 6-12 really know what a vagina is?

A boy may have a problem with his penis, with ejaculation, and with moral about sexual lust (pleasure). That is a sexual neurosis he wants to solve with a transition to another non-genital gender identity. The other way around the same is said about a girl. It is said: "Transgender people usually figure out their 'gender identity' during childhood". Therefore, the desire of changing the gender identity is a self-identity problem and a sexual disorder except in cases of relevant sex organ abnormalities, which we can't understand as a mental disorder.

Are gays and lesbians a kind of "Transgender"? No! It is appropriate to understand homosexuality as a neurosis or 'mental disorder'. The world is full of people with all kinds of mental disorders. To abuse the Archetype of "Marriage" a spiritual crime, is the only absolutely despicable homosexual criticality! The rest is a private matter.

Transgender and Transsexuals are unable to change their genetics. Transsexual individuals cannot acquire the reproductive abilities of the sex to which they transition. Is a young boy or girl aware of these facts?

Therefore, we must see the transgender issue as a childhood mental disorder in a world with soon 8 billion people where creating an outstanding “Self-Identity” (with the given genitals) is nearly impossible. The question arises: what generates the desire of changing the ‘gender identity’ so early during childhood?

There must be a very serious family and social environmental neurosis or disorder that creates such a sick desire. Too many careless mothers and fathers shape the mind of a fetus in critical ways, already during prenatal times.

It is said, that the “real gender” is the one that individuals prefer. But the genes since prenatal times, do not change and will never change. The transgender individual here cheats himself (herself). This is again a mental disorder.

There is no reliable statistic and no comparative parameters available online that give a clear picture about all transgender details and about the related population, environment and groups in specific countries. We have the suspicion that all the stories about transgender are a blatant scam.

But the transgender problem may lie in another very hot problematic context, explored later in this report.

Motives to Become Transgender

Nowadays already children from the age of 6 up to 12 or 16 want to “transgender”. Are these children at age 6-12 victim of the (pseudo-scientific) transgender concept or of mad parents? In the context of the mental development of a child or adolescent it appears to be in general a very serious mental disorder we must see also under the conditions of the parents, family, social environment, and use of social media such as Facebook.

De facto there are much more boys than girls that start the “Transgender Theater” for their weird gender issue. What else could be the reason if not a mental disorder in the context of personal identity development?

This question is not answered: do transgender girls have penis envy? And do boys have womb envy?

We assume: individuals that identify as transgender want to be exceptional, to get special attention, to provoke father or mother, or to terrorize the family environment. Girls get more attention, more ‘cuddles’, more tenderness, more understanding, and more emotional care than boys.

Or do boys simply want to feel the clothes the other gender (girl or boy) has? Or is it about fun? Or sexual curiosity?

What are the motives from an individual aged 6 to 12, 15 to 25, and 30 or even 40 and 50 to transgender?

What is the motive that a boy suddenly wants to go to the girl’s toilet at school? What is his benefit or drive? Or the other way round: What is the boy’s fear about going to the boy’s toilet? The boy may be embarrassed or inhibited urinating in the urinal next to a classmate. Or is it an interest in female matters in the female toilet?

Are there really girls that want to go to the boy’s toilet at school for gender reason? And what could be their motive and drive?

It could simply be a dysphoria, a serious unhappiness, an unhappy feeling about the body. But maybe it is much more unhappiness with father or mother; the parental failure due to their own self-identity disorder.

Too many people forgot that a man is a man and a woman is a woman and that is by nature not the same; both together form a unity of love and self-development (also to forge the self-identity) that always matters.

We observed that in advertising on television there are more lovely sweet girls ('angels') than boys as the center of attention. In general, boys are addressed with rougher words and handling; they get less understanding and attention. Logically, there are boys that wish to be in the girl's place to get everything that girls get (from mum, dad, and others). Herein lies another root of mental disorder in the infant's transgender interest.

Normally, between the ages of 6-12, boys and girls have not all-round developed their "identity" and are not aware of the deeper meaning and consequences of transgender matters. They are simply obsessed with the wish of a gender-change.

If a huge majority of parents are stucked in their own post-puberty (adolescence), they can't guide their kids adequately. It can't be a surprise that nothing better can come out for their children.

The Etymological Scam

Etymological use: "Trans" means "across", "go beyond", "pass through", "go over", "to cross", "on the other side"; in combined use: "transatlantic", transform, transmit, translation, transaction, transalpine, etc.

From here we get the construct "trans-gender", which means: to go beyond gender by ignoring the given sex by birth. This elimination is an artificial construct and a scam.

"Gender" means the male and female sex by birth. How can anyone use the term 'gender' now for other options of 'gender' than what has been by nature understood up to today? This is simply an intention to corrode the real meaning of 'gender', to seed confusion and doubt thereby making people mad.

Since millenniums, "Gender" is the basic term that specifies male or female identity based on the given sex by birth. The hidden plan of its constructors ('experts') is: the genuine concept of human evolution must be destroyed with all its evolutionary roots! People's natural self-identity development must be crushed."

Today the term 'Gender' is used for any kind of individual (subjective) identity in psychological terms by excluding sexual organs. 'Self-Identity' is a purely psychological term. Therefore, anything that has to do with "Self-Identity" is psychological and includes the given sex by birth. Sex always implies many psychological and human values issues.

The new use of this term 'gender' interrelates 'just as you like' with all possible sexual orientations based on genitals, sexual preferences, or simply on an individually constructed 'personal identity', occasionally including or excluding sexual interest, activities and attractiveness. This is blatant child abuse here: "You can become a girl." And: "You can become a boy."

The use of the terms 'trans', 'gender', and 'transgender' is artificial, weird, confusing and decomposing the biologically given 'male-female' concept and especially the archetypes of 'man' and 'woman' with the consequence of dissolving also the archetype of 'father' and 'mother' and 'family'.

We conclude: Transgender is "trans-natural" that means being above or beyond nature. Exactly this is the aim of its hidden inventors: to destroy all natural biological and archetypal principles and human values for human development.

The confusion with words reaches absurdity: transmen, transwomen, bigender, pangender, genderfluid, agender, third gender, genderqueer, and cross-dressers. Its experts show herewith their own mental disorder.

“Sex” refers exclusively to the biological features: chromosomes, the balance of hormones, and internal and external anatomy. Each human is born as either male or female, with rare exceptions of those born intersex who may display characteristics of both sexes at birth. Some experts say that ‘gender’ is more complex and encompasses more than just two possibilities.

Perverse fantasies have no limits. Everything is allowed.

It is often said that sex is a matter of the body, while gender occurs in the mind. This is a weird verbal construction using the word ‘sex’ in another context than ‘gender’, which is normally also the term for ‘sex’.

Men may play female characters because they are treated nicer. Women create a male character so that they are more respected and taken more seriously. But this is not simply about playing a ‘character’. It’s a game for fun or it’s a mental disorder. We can even consider such ‘games’ as something ‘normal’.

Gender Characters

- There are a 100 gender differences in the brain respectively between males and females.
- The gender differences are deeply rooted in human nature and human biology.
- There are also differences between genders in psychological terms.
- Several structural elements in the human brain differ between males and females.
- The differences between genders extends beyond what the eye can see.
- Differences between men and between women: Body shape, physical strength, muscles, talents, self-expressions, practical skills, interests, caring, self-expressions, artistic skills, dancing skills, soldier, lover of nature and species, dominant character, spiritual character, contemplative character, musician, poet, scientist, thinker, intuition, sensitivity, sensuality, empathy, etc.
- There are also differences between men and women in wanting sex, experiencing sexuality, sexual excitement and orgasm (time, intensity, and waves).
- Females have other emotional ways to attract a man, to express love for a man, and to be gentle in general.
- Well known is: after sex a man wants to sleep and a woman wants to cuddle.
- Females have body care, and deal with body pain or dysfunction in a different way.
- Boys as well as girls already from the very early age need a lot of attention, care, emotional care, love, understanding, support, security, positive communication, comfort, consolation, guidance, exploring the worlds around, etc. Fact is girls get much more emotional care, love and attention than boys.

Girls and Boys in Mass Media and Every Day Life

- Girls occupy more space and get more focus on TV than boys.
- Girls on TV get more ‘lovely’ emotional attention than boys.
- Girls are always attractive, sweet, little angels, cared, sensual
- Girls get less physical and psychological punishments
- Boys are less attractive, rather operative, less cared
- Boys are rarely ‘sensual’, not outstanding attractive and sweet
- Boys are less emotional, presented as strong and intelligent
- Boys get more physical and psychological punishments
- ‘Weak’ boys want to be female to get all that girls get
- There are much less girls that want to be treated as boy
- What are the differences between boys / men in general?

- What are the differences between girls / women in general?
- There are without doubt biological differences between boys / men and girls / women
- What is the difference between a woman and a pregnant woman or a mother?
- There are without doubt biological differences between girls / women and boys / men

“I am in the wrong body” is not comprehensible; comprehensible is:

New Laws

- Transgender and intersex students should not have to declare their birth gender when applying to university sports teams.

- RBS and Lloyds will offer more ‘gender neutral’ titles to make ‘transgender people feel welcome’.
- Transgender customers with HSBC can now choose from ten gender neutral titles.
- Those who do not identify as a Mr, Mrs, Miss or Ms will be able to choose from a range of options.
- Options: Mre, (abbreviation for mystery), Msr (a combination of Miss and Sir), Ind (short for individual).
- HSBC said people who do not identify as a Mr, Mrs, Miss or Ms can choose from a range of options.
- HSBC hopes to give transgender customers a ‘better, more personal’ banking experience.
- More options: M, Myr, Mx, Sai and Ser. Misc (miscellaneous), Pr (abbreviation for person).
- Such constructions are an expression of its authors: very absurd, neurotic, and a perverted mindset!

Students and Transgender

- Many universities are already advise students and staff not to use ‘gender-offensive’ terms such as ‘he’ or ‘she’ to describe people that could be either male or female. That’s hypocrisy?!
- Guidance offered in a leaflet by the students’ union advises against using traditional pronouns, arguing that doing so suggests there are only two genders. That’s brainwashing!
- Deliberately using the wrong pronoun for a transgendered person is an offence (union’s code of conduct).
- Sweden’s health minister has promised more support for gender identity clinics as it emerged that the number of children claiming to be in the wrong body has risen 100 per cent each year. How many?
- And terms such as ‘mankind’, ‘manpower’ and ‘manmade’ are frowned upon by academics if used in essays.
- Some universities have threatened to deduct marks from students for using ‘gender-offensive’ phrases.
- We conclude: The transgender concept is gender-offensive.

Permanent Adolescence: Arrested Emotional Development

- Billions of people are suffering from an epidemic of arrested emotional development.
- This particular illness is characterized by some combination of: addiction, greed, immaturity, fear, blame, shame, resentments, anger, confusion and suffering.
- The vast majority of humans are stuck in adolescence exhibiting behavior like lying, negative attitudes, disobedience and disrespect, drug and alcohol abuse, depression, and issues of sexuality.
- It is the constant pursuit of mindless hedonistic and decadent pursuits.
- The cognitive effect of exaggeration and over-simplification leading to irrationality and confusion.

Mental Degeneration of the World Population

- If the fundamental human values such as girl, boy, woman, man, father, grand-father, mother, grand-mother, and the 'Archetype Marriage' (for man-woman relationship) are abused and eliminated, what remains then for future generations?
- If everyone of age 14, 25, 35, 45 and 55 is a teenager, then there is no mature adult support and no proper education. In general there is no more mental and spiritual development.
- Human values give indispensable orientation. What will be the problem of the future generations if all fundamental (archetypal) human values and principles are eliminated?
- Mental functions can be ignored, distorted, stunted, abused, perverted, made ridiculous, infantilized, stupefied, etc. How will the young generations in the future develop?
- Critical mental functions reduce capacities of making a living, finding the truth, contributing to human development, etc.
- Critical mental functions create criticalities in personal life, in relationship life, in love and sex matters, in family life, etc. Stupidity can't recognize itself!
- The more the brain is damaged (e.g. by contamination) and the mental functions malformed or stunted, the less people can become aware of their own mental and factual deficiencies.

Social Media Contamination and Effects on the Mind

- 91% of 16-24 year olds use the internet for social networking
- Social media has been described as more addictive than cigarettes and alcohol
- Social media destroys the development of the mental functions and of a healthy self-identity
- Rates of anxiety and depression in young people have risen 70% in the past 25 years
- Social media use is linked with increased rates of anxiety, depression and sleep disorders
- Cyber bullying is a growing problem with 7 in 10 young people saying they have experienced it
- Nine in 10 girls say they are unhappy with their body; they want to be 'something else'

Potential negative effects of social media on health:

1. Anxiety and Depression

- One in six young people will experience an anxiety disorder at some point in their lives.
- Identified rates of anxiety and depression in young people have increased by 70% over the past 25 years.
- Young people say four of the most used social media platforms make their feelings of anxiety worse.
- 80,000 children and young people in the UK have severe depression.

2. Sleep and Disorder

- Poor mental health can lead to poor sleep and poor sleep can lead to states of poor mental health.
- Sleep is particularly important for teens and young adults due to this being a key time for development.
- The brain is not fully developed until a person is well into their twenties and thirties.
- Teens need around 1-2 hours more sleep every night than adults.
- Poor sleep is linked to a wide range of both physical and mental health conditions in adults including high blood pressure, diabetes, obesity, heart attack, stroke and depression.

3. Fear of Missing Out

- The concept of ‘Fear of Missing Out’ is relatively new and has grown rapidly in popular culture since the advent and rise in the popularity of social media.
- The term is particularly used by young people, with digital language research showing that 40% of parents do not know what the term means.
- The sharing of photos and videos on social media means that young people are experiencing a practically endless stream of others’ experiences that can potentially fuel feelings that they are missing out on life – whilst others enjoy theirs – and that has been described as a ‘highlight reel’ of friends’ lives.

Contamination

Around 100,000 chemical products are used in Europe; probably even everywhere around the world. More than 700 carcinogenic elements are present everywhere in the environment of everyday life.

- Chemicals in food, water, soil, air, furniture, devices, computers, carpets, cars, paintings and clothes.
- Heavy metals in high concentration can also be found in animal bowels, fish and seafood.
- Poisonous substances can be found in food, in soil, in air, in sea, and in the body of humans.
- About one in three people in the UK will get cancer due to contamination (Germany: 1 of 4).
- Animals are fed with antibiotics so they grow bigger, faster. Result: people are getting sicker.
- Sewage that goes into the sea; is full of traces of medicines. Eating fish, these chemicals go into our bodies.

Species and Gender-bending Chemicals

Feminization of the males of numerous vertebrate species is now a widespread occurrence.

Fishes have been badly hit by man-made gender-bending chemicals.

Wildlife has been found to be contaminated with more than 400 different chemicals.

Affected species: Polar bears, whales, falcons, eagles, fishes, high-flying falcons and eagles, bony fishes, amphibians, reptiles, birds and mammals, alligators, turtles, frogs, male herring gulls, starlings, otters, and many more.

A research shows that a host of common chemicals is feminizing males of every class of vertebrate animals, from fish to mammals (including people).

Fish Changing Sex (Intersex Fish)

- Medications found in water are changing the sex of fish. Male fish are being ‘feminized’ by river pollution.
- British rivers contain enough synthetic female hormones to change the sexual characteristics of male fish.
- One potentially devastating threat to wild fish populations comes from estrogen.

- Chronic exposure to estrogen led to the near extinction of the lake's fathead minnow population.
- Fishes were showing similar changes (in sex) in France, Switzerland, Belgium, Germany and Finland.
- Fishes in US rivers: chemical pollution disrupts their hormones, blurring the line between male & female.
- Something in the Water Is Feminizing Male Fish. Are we next or already affected like fish?

Humans and Gender-Bending Chemicals

- Bisphenol A is used in the linings of food cans, plastic bottles and dental sealants, and phthalates added to plastics such as PVC and glues, and used in food wrapping, cosmetics and baby powders among other applications; also for flame retardants in furniture and electrical goods.
- PCBs, now a banned group of substances, is still widespread in food and the environment.
- These chemicals - found in food packaging, cleaning products, plastics, sewage and paint - cause genital deformities, reduce sperm count and even turn males into females.
- Boys with raised levels of phthalates were more likely to have smaller penises and undescended testicles. They had a shorter distance between their anus and genitalia, a classic sign of feminization.
- Sperm counts in the West have fallen over the past 30 years by 65%.
- Baby boys exposed to chemicals in pregnancy are born with smaller penises and feminized genitals.
- Men: Abnormal testes, smaller penises, genital abnormalities, reproductive failures, abnormal sperms.

Atrazine and Feminization of Boys

- Atrazine is one of the most widely used pesticides (contaminant of ground and surface water) in the world.
- Atrazine causes hermaphroditism in frogs (turning males into egg-laying females).
- Humans are exposed to Atrazine without knowing it and without our consent many times.
- This and many other chemicals end up in our tap water, the water we shower and bathe in.
- Elevated concentrations of Atrazine in drinking water have been associated with birth defects.
- Atrazine exposed males had greatly reduced testosterone levels and noticeable de-masculinization.
- It has also been linked to breast cancer and is carcinogen, which has been banned in the European Union.
- If Atrazine among other pesticides is powerful enough to change the actual sex of a frog, it will change us.
- Men seem to becoming more and more feminine, softer, and coming out as transgender or gay.

Chemicals Alter Gender

- Pregnant women contain greater amounts of chemicals thus release more of it with every excretion.
- The source of gender-altering pollutants is due to man-made chemicals that are being released globally.
- These chemicals have an effect on the sex of many humans because of constant exposure.
- Chemicals mimic human hormones and trigger changes in the sex-determining process of unborn children.
- This hormonal influence on the sex-determining process has led to a decrease in the male/female ratio.
- Other effects influencing the sex of an individual: a decrease in number and quality of sperm.
- Due to the deficiency of male's reproductive system, these chemicals affect a male as early as birth.
- Sex-altering pollutants come from many sources.
- One source that is becoming more visible is water pollution through pharmaceuticals.
- Some pharmaceuticals found in water analyses are anti-depressants, anti-seizure drugs, and birth control.
- Pharmaceuticals are the largest contributor to the gender-altering pollution in the water.
- Chemicals that flush down the toilet feminize wild fishes and reduce sperm quality.
- Over 200 chemicals have been found in rivers which had characteristics similar to estrogen and antidepressants.

- Endocrine disruptors, chemicals in pesticides, detergents, antidepressant drugs, contraceptive pill and cosmetics are also responsible for change in sex and behavior of fish.

Toxic Chemicals in the Body of a Fetus and Infant

- 275-400 elements that should not be in the body of a fetus and infant: industrial toxins such as dioxins, PCBs, mercury, phthalates, pesticides, flame retardants, biphenyl A, Glyphosate, etc.
- Babies and infants are exposed to chemicals through contact with air, water, soil and products such as carpets, clothing, furniture and household products, as well as air, water, soil, food, toys, and so on.
- Tiny doses of chemical residues can have a dramatic effect on the developing fetus. Levels of mercury can harm the developing fetal brain. Tiny amounts of dioxins and PCBs can damage the developing immune and nervous systems. Pollutants and heavy metals cross the placenta, and some also enter via breast milk.
- Chemicals accumulated in different body parts including adipose (connective) tissue, brain, bone, blood, liver, placenta and semen, and also found in breast milk.
- We pass on this chemical body burden to the next generation.
- Adults are at risk of having more than 800 toxins in their body.
- The average woman puts 515 synthetic chemicals in her body every day without knowing.

Epigenetics and Gender Effects

- Epigenetic effects (on to the next generation), chemical modifications of the human genome alter gene activity without changing the DNA sequence, may have a major influence on sexual orientation.
- Some experts suggested that epigenetic effects might lead to homosexuality when they are passed on from father to daughter or from mother to son.
- Specifically, inherited marks that influence a fetus's sensitivity to testosterone in the womb might “masculinize” the brains of girls and “feminize” those of boys, leading to same-sex attraction.
- Sexual orientation can be decided through epi-marks, which are temporary switches in a fetus’ DNA that exist while in the womb and shortly after birth.
- Genes are basically the instruction book, while epi-marks direct *how* those instructions get carried out. For example, they can determine when, where, and how much of a gene gets expressed. There’s No Gay Gene!

Contamination and Transgender

- Chemicals are in the womb that babies are most vulnerable; every one contained hazardous chemicals.
- Transgendered men do not become women, nor do transgendered women become men.
- Adolescents are “trying out being transgender” to gain attention – or make their father or mother angry.
- Two-year-old children are at risk of a bewildering array of gender-bending chemicals in such everyday items as waterproof clothes, rubber boots, bed linen, food, nappies, sunscreen lotion, moisturizing cream.
- The results build on earlier studies showing that British children have higher levels of gender-bending chemicals in their blood than their parents or grandparents.
- Prominent chemicals are: dioxins, PVC, flame retardants, phthalates (extensively used to soften plastics) dioxins, PCBs and biphenyl-A, all of which mimic the action of estrogen in the body.
- Other research has documented a connection between prenatal phthalate exposure and “feminization” of male genitals, including smaller penises.
- The chemical, which is used in tin lining, is so-called ‘gender bending’ because it has been linked to breast growth in men.
- Canned foods contain a ‘gender bending’ chemical, which has been linked to serious health issues.
- BPA was found in 40 percent of food cans although the chemical has been banned from baby products and plastic water bottles because of its toxins.
- The substance has been connected to a slew of health issues including cancer, birth defects, diabetes, obesity, male infertility, and birth defects.
